ORDINANCE NO. __341__ of 2020

AN ORDINANCE OF THE BOROUGH OF NORTH APOLLO, COUNTY OF ARMSTRONG, COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE 338 OF 2020 FOR THE PURPOSE OF OPENING STREETS UPON PETITION BY PENNTEX VENTURES, LLC

WHEREAS, pursuant to the authority vested in the Borough of North Apollo (hereinafter "Borough") by the Pennsylvania Borough Code, 8 Pa.C.S. §1731 and §1732, the Borough conducted a properly noticed hearing on February 3, 2020 at which Borough Council granted the petition of PennTex Ventures, LLC to open certain streets identified in the said petition;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of North Apollo, Armstrong County, Pennsylvania, as follows:

Article 1: All of that portion of the area identified as "Unopened Street (Maple Street)" as shown on Exhibit A and further identified as "Area to be vacated by the Borough" is hereby vacated pursuant to the Borough Code;

Article 2: All that portion of the area identified as "Unopened Alley" as shown on Exhibit A and further identified as "Area to be vacated by the Borough" is hereby vacated pursuant to the Borough Code.

Article 3: This ordinance shall be effective as of the date indicated below.

Article 4: If any word, phrase, section, sentence, clause or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, invalidity or illegality shall not affect, or impair any of the remaining words, phrases, sections, sentences, clauses or parts of this Ordinance. It is hereby declared to be the intent of the Borough Council of the Borough of North Apollo that this Ordinance would not have been adopted had such unconstitutional, illegal or invalid word, phrase, section, sentence, clause or part thereof been included therein. The Borough of North Apollo reserves the right to amend this Ordinance or any portion thereof from time to time as it deems advisable in the best interests of the promotion of the purposes and intent of this Ordinance and the effective administration thereof.

Article 5: All ordinances, parts of ordinances, or resolutions inconsistent with this ordinance are hereby repealed to the extent of such conflict.
