## **ORDINANCE NO.** 344-2021

AN ORDINANCE OF THE BOROUGH OF NORTH APOLLO, COUNTY OF ARMSTRONG, COMMONWEALTH OF PENNSYLVANIA, TO PROHIBIT THE DUMPING OF RUBBISH AND ESTABLISH A \$500.00 FINE FOR PROHIBITED DUMPING

WHEREAS, the Borough finds that the dumping of junk/salvage, rubbish, garbage, and other discards in the Borough is unsanitary, unsightly, constitutes a threat to the health, safety, and welfare of Borough residents, contributes to blight, and reduces property values in the Borough;

NOW, THEREFORE, the Borough of North Apollo enacts the following ordinance:

<u>Section 1</u>. The dumping of junk/salvage or rubbish is prohibited. This prohibition shall not, however, preclude the placing or disposing of junk/salvage or rubbish in any area or manner designated and authorized by the Borough.

<u>Section 2.</u> "Dumping" is hereby defined as the intentional, unauthorized act of depositing, placing or scattering junk/salvage or rubbish alongside of federal, state, county, and/or Borough roads or within 100 feet of either road shoulder on properties, private or otherwise, which adjoin said roads.

"Junk/salvage" is hereby defined as any discarded material such as metal, paper, rags, or anything that is regarded as worthless, meaningless, contemptible, or mere trash, which shall include both organic and inorganic material.

"Rubbish" is hereby defined as any and all discarded metal, plastic, glass, ceramic, and organic materials; animal feces or offal; pasteboard; rags; mattresses; discarded furniture or appliances; discarded clothes, shoes and boots; leather; carpets; broken glass; crockery; bottles; excelsior; floor sweepings; metal packing boxes and barrels and broken parts thereof; cans; tires; household refuse generally including garbage; non-salvageable demolished building materials; and any other material which by reason of its nature might give off toxic chemicals, obnoxious odors or dust, or be unsightly or a fire hazard or harbor rats, vermin, insects or termites to the detriment of the health, safety, or general welfare of the residents of the Borough.

<u>Section 3.</u> Any person who violates this ordinance shall be subject to a fine of \$500.00 for each violation.
